HERE IS HOW IT WORKS: Please read carefully.

1. We will provide you with a FREE 10x10 Booth Space at the Event.
2. Upon **receiving an invoice**, we will buy up to TWO kegs at \$75/each from your brewery (**\$150 total for the event**).
3. Each brewery will give “taste” samples to the attendees, please do not fill the glass.
4. Each brewery will need to provide their own bucket and pitchers.
5. We will provide wrist bands for attendees that have paid for a ticket. People with a different colored wrist band have not paid for a ticket so please do not serve them.
We do not allow anyone under the age of 21 at this event.
6. We will be giving out a custom glass with our logo on it.
7. **Set up will be from 10am – 11:30am and tear down will begin promptly at 4pm.**
8. Vendors are responsible for any damages they cause to City property.
9. If you bring canned beer, you must take those cans back with you or place them in the dumpster in a bag. **Please do not leave empty beer cans in, on, or near the trash bins provided at the event.**
10. We will advertise the “PINTS IN THE PARK” throughout the area and your name or your logo will be included.
11. We strive to make the Pints in the Park a Zero Waste event. All vendors will utilize only biodegradable plates, napkins, utensils, and recyclable cups. The goal of a Zero Waste event is to plan and distribute only materials that are recyclable, compostable or reusable.
